INVITATION TO BID FOR THE

Public Bidding for the Supply and Delivery of 1,000 units of Volumetric Water Meter ½"

1. The Carcar Water District (CWD) intends to apply the sum of Two Million Pesos (P 2, 000, 000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Public Bidding for the Supply and Delivery of 1,000 units of Volumetric Water Meter ½". Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The CWD now invites bids for the Public Bidding for the Supply and Delivery of 1,000 units of Volumetric Water Meter ½". Delivery of the Goods is required within 30 calendar days after receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project within three (3) years prior to the deadline for the submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from CWD and inspect the Bidding Documents at the address given below during office hours (8:00am-5:00pm).

5. A complete set of Bidding Documents may be purchased by interested Bidders starting November 24, 2021 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Thousand Pesos (PHP 5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The CWD will hold a Pre-Bid Conference on December 2, 2021 at 2:00 PM via Zoom Meeting which shall be open to all interested parties. During the Pre-Bid Conference interested parties may conduct a Product Presentation/Demonstration of their products/services to the BAC.

7. Bids must be duly received by the BAC Secretariat at the address below on or before December 15, 2021 at 2:00

PM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on December 15, 2021 at 2:00 PM via Zoom Meeting. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Only ONE representative per bidder is allowed to attend during the scheduled BAC activities: Pre-Bid and Bid Opening.

9. The CWD reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
